

# **Passenger Assistant**

## About the service

The Special Educational Needs (SEN) transport service sits within the Education directorate. The Directorate covers a range of services to Schools including support, standards and performance, managing school admissions and transport. The SEN transport service provides specialised support for home to school Transport to children and young people living in the Borough of Kingston upon Thames and the London Borough of Richmond to ensure that children and young people with SEN needs have the same opportunities to education as their peers. Usually operating during [term time], our vehicles will travel to children's homes, and safely support them whilst they travel to or from their destination.

## About the role

The role of Passenger Assistant will be required to supervise special educational needs (SEN) children whilst travelling on transport for the London Borough of Richmond and the Royal Borough of Kingston upon Thames, based from either our Richmond (presently at Twickenham) Depot or Kingston (presently at New Malden) Depot.

In the role the Passenger Assistant will

- Need to be aware of incident reporting and parent not at home/parent late procedure, to ensure all paperwork is in place and on board e.g. Pupil medical information, registers, parent not at home form etc.
- To assist the driver in the operation of any safety/adaptive equipment whilst ensuring all passengers who use safety and adaptive equipment are seated and secured in appropriate seats, in accordance with manufacturer's instructions, and to ensure all passengers wear seatbelts and to assist in securing wheelchairs where necessary.
- To work as a team and maintain a good atmosphere in the vehicle, to demonstrate sound work ethics, to have good customer relations, a polite friendly attitude with parents/ guardians/ carers/ schools,
- To be aware of the Data Protection Act and to deal with residents and the members of the general public in a courteous and respectful manner at all times.
- To assist the driver in the operation of any safety/adaptive equipment whilst ensuring all passengers who use safety and adaptive equipment are seated and secured in appropriate seats in accordance with manufacturer's instructions
